#### 2. Declarations of interest:

No declarations of interest were received.

#### 3. Minutes of Previous AGM

The minutes from the 2022 AGM, held on 18 May 2022 were proposed as accurate by Cllr Armstrong, seconded by Cllr Nelsey and agreed by those present. Cllr Robinson signed off the minutes on behalf of the Council.

#### 4. Election of Chair and Vice-Chair

# 5. Financial Matters:

a. Summary of Year End Accounts for 22/23, prior to Audit sign off arrangements.

In summary BPC, started the 22/23 year with £42, 466.03 in the bank. Incoming total for 22/23 was £13, 545 Expenditure total for 22/23 was £17, 810. 93 Year End total = £38, 200.10
